

D. Other Terms



2. It is also agreed that the University and the MoU Partner will provide all its services on "best efforts basis" only.

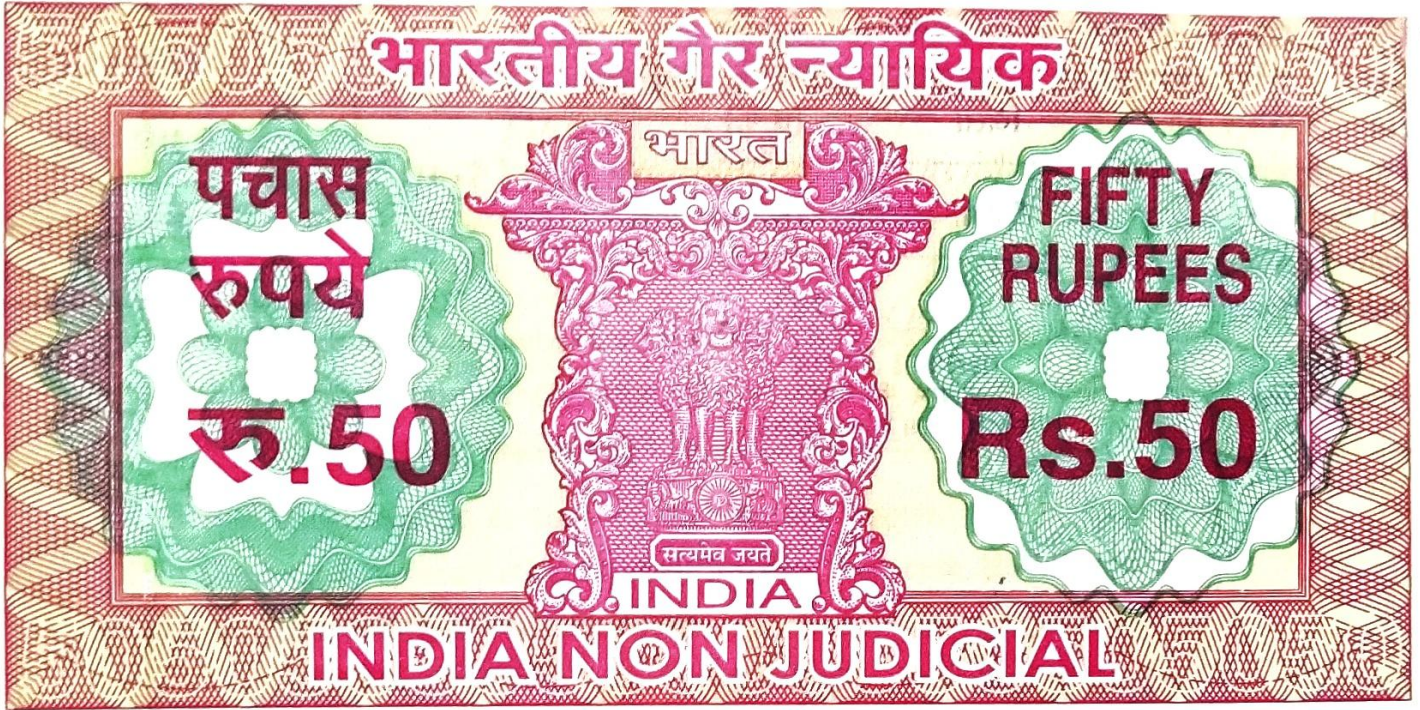




